Open Show breed-specific extra class guidelines

Chester White Maternal Plus

Purpose: To recognize those individuals who have utilized the CPS Herdsman Performance Program and to promote the maternal strength of the Chester White breed.

- A. Entry must come from a dam with an SPI of 110 or higher (top 10% of breed).
- B. Entry must be farrowed Dec. 1, 2009 - Feb. 15, 2010
- C. Entry must be of high-quality underline -- 6 & 6 or better.
- D. Entries will be put in a "special designated class" with class winner eligible for championship honors.
- E. One free entry per consignor, with no limit on number of entries per farm (balance of entries paid for by consignor).

Poland China Herdsman Boar and Herdsman Gilt

- A. Come from a litter with 21-day weights printed on the pedigree. EPDs will be available if owner or breeder has enrolled in performance data.
- B. Entry must be documented stress negative by mating or by test on or prior to making entries.
- C. Herdsman class designation must be made at time of entry.

Open Show reminder; for all breeds

1. Payment must accompany all entries.
2. No clipping is allowed in the barns.
3. A Premise ID number is needed.
4. Original pedigrees and health papers must be submitted at check-in at the show.
5. All hogs must meet all registry requirements. Check individual breed rules and regulations for registry.
6. All animals must have a minimum of six (6) quality teats on each side to be eligible to show.
7. Any evidence of fresh ear notes will automatically disqualify the animal from both the show and the sale.
8. All Berkshire, Poland and Spotted entries must have stress status listed on pedigree. Berkshire entries must be stress negative. Poland and Spotted animals may be stress negative or stress carriers. Stress positive Polands and Spotted animals are not allowed to show and sell.
9. Prior to the event, more specific reminders will be mailed to all exhibitors.
10. By July 1 -- all exhibitors must contact the ABA office with ear notches of Berkshire entries and the CPS office with ear notches and registration numbers of Chester, Poland and Spotted entries. You may mail, fax or e-mail this information.

Summer Type Conference & Team Purebred Health Regulations - Junior & Open

- 1) All swine must be accompanied by an official health certificate issued June 10, 2010, or after, signed by the veterinarian in charge of the consignors' operation. Two copies are required per animal of all hogs entered into the open show and sale. It is permissible that all hogs are listed on the same health paper as long as two copies are available for each hog consigned for the sale. Premise ID number required.
- 2) All hogs should be identified by ear-notch, except crossbred boars. See Rule #8.
- 3) All swine originating from outside the state of Illinois are required to obtain an entry permit. Permits are available 24 hours per day, seven days a week, by calling (217) 782-4944.
- 4) Pseudorabies: Swine may be exhibited that originate from a validated, qualified PRV negative herd or must be tested negative for PRV on or after June 10, 2010. Please list validation number and date of last test on health certificate.
- 5) Brucellosis: If hogs originate from a brucellosis free state and/or validated brucellosis free herd -- they need not be tested. If you do not qualify to the above terms, hogs must be bled negative for brucellosis on or after June 10, 2010. Results must be printed on health certificate.
- 6) All breeding swine entered into the open show and sale must be vaccinated for 6-way lept including bratislava. Please list product used and vaccination date on health paper.
- 7) The following statements must be printed on all health papers:
 - a) No raw garbage fed
 - b) No PRV in herd in past 12 months
 - c) No PRV vaccine used
 - d) Herd is not under quarantine
 - e) Hogs have not been exposed to hog cholera
- 8) Crossbred boars. The same protocol for health regulations apply, however, ALL crossbreds must be identified by a state issued ear tag. All crossbreds must be tagged with this ear tag and identified on the health paper by this tag number. This is a Federal requirement.
- 9) Team Purebred and Open Class Exhibitors: MUST follow the above guidelines fully. Please review your health papers BEFORE arriving in Springfield.

General Requirements

- **Entries must be postmarked by May 25, 2010.**
- All animals must be farrowed on or after December 1, 2009.
- All Junior entries must meet the same health requirements as the open show—see *previous page*. The health requirements are also available on the Team Purebred Website.
- Gilts will show by age and barrows will show by weight.
- No entries will be accepted at the show.
- All gilts and barrows must be registered Berkshire, Chester White, Poland China or Spotted Swine.
- Entries may be purchased animals, but must be owned by the junior exhibitor, the exhibitor's family name or exhibitor's farm name on or before April 30, 2010.
- All entries must meet Breed classification standards, call for details or view our Website if you're not sure of these rules.
- Chester White barrows & gilts are guaranteed to be stress free.
- Berkshire gilts & barrows must have the negative stress status denoted on pedigree. The ABA will test the top five barrows and gilts for stress and they **MUST** test negative. All premiums will be held until passing the stress test.
- If you want to sell your junior gilts, they must also be entered in the open show (separate entry form, mailed to the breed office). Females entered in the open show must meet all the requirements that are printed in the rules and regulations for that event.
